1.	To pay charges for each water/sewer services as fixed from time by the governing body until such services to be disconnected.
2	In the event of failure to pay water/sewer charges with the due dates fixed by the governing
2.	body or of failure of the occupant of the premises to conform to the ordinances and regulations
	established by the governing body regulating the use of the water/sewer system, that the
	municipality shall have the right to discontinue the water/sewer system services at its election,
	pursuant to five (5) days written notice of the municipality's intention, until all delinquencies
	and any reconnection fee imposed are paid in full or until any failure to conform to this
	ordinance or regulations issued there under is eliminated.
3.	To be bound to the rules, regulations, resolutions or ordinances enacted or adopted by the
	governing body applicable to the municipality's water/sewer systems.
4.	By signing below, I agree to pay all amounts within 30 days of when such amount(s) are
	incurred. I agree that interest will accrue on all past-due amounts at the rate of 18% per annum
	(1.5% per month) until paid in full. In the event any amount(s) is/are referred to a third-party
	debt collection agency, I agree that in addition to any other amount(s) allowed for by law, (such
	as interest, court costs, reasonable attorney's fees, etc.) I will also be responsible for a
	collection fee of up to 33% of the principal amount(s) owing as allowed by Utah Code
	Annotated, sec. 12-1-11. The terms of this paragraph shall apply to all amount(s) incurred by
	me or by any individual for whom I have legal responsibility whether such amount(s) are
	incurred today or after today.
5.	The undersigned agrees to be bound by the rules, regulations, resolutions and ordinances
	enacted or adopted by the governing body of the municipality applicable to the municipality's
	water/sewer systems.
