## MORONI CITY PARADE

### PARTICIPATION WAIVER, RELEASE OF LIABILITY, AND INDEMNIFICATION AGREEMENT

PLEASE READ THIS DOCUMENT CAREFULLY BEFORE SIGNING. BY SIGNING THIS AGREEMENT, YOU ARE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE MORONI CITY, ITS OFFICIALS, EMPLOYEES, AND VOLUNTEERS.

#### 2. Strict Safety Rule: No Throwing of Candy or Items

##### MANDATORY SAFETY REGULATION:

For the safety of spectators and children, **NO candy, prizes, promotional materials, or any other items may be thrown from moving vehicles, floats, or trailers at any time during the parade.**

- **Allowed:** Participants walking alongside the vehicle/float may gently hand out candy or items at the curb line.
- **Penalty:** Failure to comply with this rule will result in immediate removal from the parade and disqualification from future Moroni City events.

#### 3. Waiver and Release of Liability

In consideration for being permitted to participate in the Moroni City Parade, the undersigned, on behalf of themselves and their organization, group, employees, volunteers, and participants (collectively referred to as "Participant"), hereby agrees to the following:

- **Assumption of Risk:** Participant acknowledges that participating in a parade involves inherent risks, including but not limited to traffic hazards, mechanical failure, animal behavior, weather conditions, and actions of spectators. Participant knowingly and freely assumes all such risks, both known and unknown.
- **Release and Hold Harmless:** Participant hereby releases, waives, and forever discharges Moroni City, its elected officials, officers, employees, agents, volunteers, and sponsors (collectively referred to as "City Released Parties") from any and all liability, claims, demands, or causes of action arising out of any injury, illness, death, or property damage sustained during or as a result of participation in the parade.

#### **4. Indemnification Agreement**

Participant agrees to **indemnify, defend, and hold harmless** the City Released Parties from and against any and all claims, losses, liabilities, damages, costs, and expenses (including reasonable attorney's fees) arising out of or resulting from the Participant's entry, actions, omissions, or failure to follow parade rules (including the strict prohibition against throwing items from moving vehicles).

#### **5. Compliance with Laws and Rules**

Participant agrees to comply with all federal, state, and local laws, as well as all specific parade rules, staging instructions, and directions provided by Moroni City officials or law enforcement. Drivers of any motorized vehicles must possess a valid driver's license and current automotive insurance.
